Affichage couleur RVB montrant, en temps réel, l'état de chaque place de stationnement dans la zone du parking.



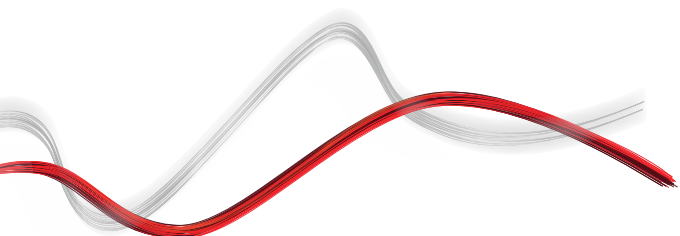
